# **AUXILIARY EMERGENCY FUND**

The Auxiliary Emergency Fund (AEF) is a national grant assistance program that provides temporary emergency help to eligible members of the American Legion Auxiliary who have been the victim of a natural or financial disaster.

The AEF was established in 1969 with a bequest from the estate of Auxiliary member Helen Colby Small of Burlington, Wisc. It continues today solely

through generous donors.

# ASSISTANCE INFORMATION

Emergency assistance grants may be awarded by the national AEF Grant Committee on a case-by-case basis up to a maximum of \$2.400.



Grant funds for Disaster Assistance applications may be used for repairs to the applicant's primary residence and for emergency expenses (lodging, food, fuel, supplies, etc.). Grant funds for Temporary Assistance applications may be used for overdue mortgage or rent expenses and/or utilities. AEF money may not be used for medical expenses or debt such as that on credit cards.

# WHO IS ELIGIBLE?

Members of the American Legion Auxiliary whose dues are current and who have maintained

membership for three consecutive years (the current year and immediate past two years), who have not received a grant (of the same type they are applying for) within the last 12 months, and are applying within six months of the disaster



are eligible to apply for a Disaster Assistance grant or a Temporary Assistance grant when:

- ★ A financial crisis hits, leaving a member without resources to pay rent/mortgage and/or utilities, and no other source of aid is readily available.
- ★ A natural disaster or weather emergency leaves a member with a damaged or destroyed primary residence and/or significant emergency expenses (lodging, food, fuel, supplies, etc.), and no other source of aid is readily available.

# APPLICATION PROCESS

Members can submit or download an application for assistance at www.ALAforVeterans.org/AEF or they can submit their application to the AEF via email at AEF@ALAforVeterans.org. Applications can also be mailed to American Legion Auxiliary National Headquarters at 3450 Founders Road, Indianapolis, IN 46268. The national AEF Grant Committee, which consists of representatives from the American Legion Auxiliary National Headquarters and The American Legion, reviews each application and awards AEF assistance according to case findings. AEF applications, supporting documents, and case files are not disclosed or released to anyone outside of the AEF Grant Committee.

# TIPS FOR GETTING YOUR APPLICATIONS APPROVED

By meeting all application requirements and submitting as many of the requested documents as possible, members can greatly speed up the application process and receive their grant funds as soon as possible.

- ★ For Temporary Assistance applications Submit a completed application, along with overdue rent/mortgage and/or utility bills, and any other documentation that helps verify your situation to the AEF Grant Committee.
- ★ For Disaster Assistance applications Submit a completed application, along with photos of all damages to the primary residence, a voided check for direct deposit reimbursement (if grant is approved), estimates for damages, and receipts for emergency expenses (lodging, food, fuel, supplies, etc.).

If you are unsure whether a document should be submitted, include it anyway. When it comes to the AEF, the more information you can provide, the better.



### BE KNOWLEDGEABLE

Familiarize yourself and your unit members with the Auxiliary Emergency Fund. Knowing about this program will make the process easier and increase the chances of the applicants receiving a grant, should you need to help a member apply. Learn the application process, what kind of documents to include with

applications, fund restrictions, and help members in need contact other organizations that might be able to assist them.
